

QUICKSTEP ANNOUNCES LONG TERM CONTRACT WITH DRONAMICS TO PRODUCE BLACK SWAN **UNMANNED CARGO AIRCRAFT**

- First full aircraft to be built at Bankstown in 30+ years
- Black Swan is a large, unmanned aircraft designed to be capable of carrying 350kg of cargo over distances in excess of 2,500klms
- Anticipated value of the firm contract: \$4.5 to \$5.5 million
- 10 initial aircraft with thousands forecast to be produced

30 January 2023: Quickstep Holdings Ltd (ASX: QHL) is pleased to announce that its Aerostructures business has secured a substantial contract award from Dronamics for the production and supply of their Black Swan unmanned cargo aircraft, with the potential for thousands of aircraft to be built for the global market.

Dronamics is the world's first cargo drone airline, based in Europe with a well-advanced global network plan. The Black Swan is a large, unmanned aircraft designed to be capable of carrying 350kg of cargo over distances up to 2.500klms

This initial contract award is the result of several months of detailed negotiations following the announcement of a manufacturing MOU at the Farnborough Airshow in July 2022. Quickstep have undertaken funded engineering work in collaboration with Dronamics during that period, which has supported design finalisation and volume production objectives.

The firm contract covers Phase 0 (Design for Manufacture) engineering; and

Phase A (Prototype) supply, on a full cost reimbursement plus fee basis, of 10 low-rate initial production aircraft. These will be split into deliveries of 3 aircraft by October 2023 and 7 further

- aircraft by July 2024. The anticipated value of the firm contract requirement is likely to be in the range of \$4.5 to \$5.5 million.
- Strong collaborative program to address global demand
- Quickstep first right of refusal for follow on production
- Potentially thousands of aircraft to be built
- Joint marketing agreement
- Compliance to AS9100D, ISO27001, ISO14001
- 5 year airframe warranty
